

## ORDINANCE NO. 2024-005

AN ORDINANCE AMENDING AND RE-ENACTING A PORTION OF CHAPTER I OF THE CITY CODE OF THE CITY OF KILLDEER RELATING TO COMPENSATION OF CITY COMMISSION MEMBERS.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF KILLDEER, NORTH DAKOTA, AS FOLLOWS:

**Section 1:** CHAPTER 1, Section 203, entitled “SALARIES” is hereby amended and re-enacted as follows:

### 1.0203 SALARIES

The salaries of the members of the governing body of the City of Killdeer, including the President of the governing body, shall be paid the sum of ~~\$600.00~~ \$800.00 per month plus ~~\$100.00~~ \$150 for each regularly scheduled city commission meeting they attend. The President of the governing body shall be paid the sum of ~~\$800.00~~ \$1200.00 per month plus ~~\$100.00~~ \$150 for each regularly scheduled city commission meeting they attend. ~~There will be three excused/paid absences allowed per year.~~ The governing body, including the President, shall be compensated ~~\$100.00~~ \$150.00 per special meeting called to order outside the regularly scheduled meetings. All special meetings held in conjunction with a regularly scheduled meeting will not be subject to compensation. The salaries for all committee members associated with the City of Killdeer shall be paid in the sum of \$150.00 per committee meeting attended, subject to the discretion of the City Commission to determine which committees qualify under this section.

**Section 2:** CHAPTER 1, SECTION 203.1, entitled “Per Diem” is hereby amend and re-enacted as follows:

### 1.203.1 PER DIEM


City Commissioners will be paid ~~\$200.00~~ \$300.00 per day or ~~\$100.00~~ \$150.00 for 1/2 day, when they are representing the City of Killdeer at meetings or events other than official meetings of the Killdeer City Commission. Four hours or less is considered 1/2 day. Commissioners will be compensated for meals and mileage at the state rate.

**Section 3:** Repeal of Ordinances in Effect. All Ordinances and parts of Ordinances in conflict herewith are hereby repealed.

**Section 4: Severability.** In the event any section of this Ordinance is held invalid by court of competent jurisdiction, the invalidity shall extend only to the section affected, and other sections of this Ordinance shall continue in full force and effect.

**Section 5: Effective Date:** This Ordinance shall be in full force and effect from and after final passage.
